The Information We Collect and How We Use It

We use the term “Personal Information” to refer to any information you provide in connection with your use of our website by which you can be personally identified. This includes when you take our Pledge and when you contact us for questions in our “Contact Us” form.

Personal Information may include such things as your name, e-mail address, and any other information which might reasonably be used to identify you.
